At our most recent board meeting, the Foundation formally adopted its **2025–2029 Strategic Plan**, a comprehensive roadmap that reflects months of collaborative effort, research, and listening. This five-year vision outlines ambitious goals for deepening community engagement, expanding philanthropic services, and ensuring our operational excellence matches the high expectations of those we serve. 


will benefit from a \$100,000 matching grant aimed at expanding its programs and

Holy Nativity \$700,000 Diamond Jubilee Capital Campaign



Holy Nativity Episcopal Church on St. Simons Island is excited to announce the launch of its

\$700,000 Diamond Jubilee Capital

Campaign. This essential project will fund the expansion of the church's facilities, allowing it to better serve both its congregation and the broader community. Rooted in its mission "To Know Christ and To Make Christ Known," Holy Nativity has long been a beloved place of worship and community gathering. In addition to regular worship services, the church hosts a variety of community organizations each month, providing a space for counseling services, 12-Step recovery programs, and local hobby groups like yoga and photography. With the addition of 1,700 square feet to Cate Hall, the church will be able to offer more meeting spaces and classrooms to accommodate these growing needs.

The building expansion will also focus on improving accessibility for all individuals, ensuring that the church remains a welcoming place for everyone, including those with disabilities. This project comes after thoughtful planning by the Vestry and Building Committee, who worked with local architect David Amos to create a master plan for the church's long-term growth. The proposed expansion includes two new classrooms and various improvements to make the church more functional and welcoming to all.

Holy Nativity has always been a careful steward of its resources, and this campaign marks the next step in ensuring the church can continue its mission of faith, love, and service for years to come. The campaign is estimated to cost \$700,000, and the church invites the community to join in this important effort.
