Statement of Values

Forward Brunswick considers these core values as foundational:

Civic Engagement: FB sees fostering civic engagement as its most important duty.

Transparency: FB conduct its business openly and will operate as if it is subject to Georgia's Open Meetings and Open Records Laws.

Anti-redundancy: FB will not duplicate or compete with the work being done by other entities, but rather, will serve to support and enhance those initiatives with which it is aligned.

Aspirational: While FB is deeply rooted in pragmatism, it will nevertheless advocate for a vision of Brunswick that moves beyond today's limited expectations.

Statement of Purpose

- Provide an inclusive forum to foster the exchange of ideas and information.
- Identify strategies and resources to overcome barriers preventing economic vitality initiatives from succeeding.
- Generate consensus and advocacy for projects and initiatives that support economic vitality within the Brunswick Community.

Structure

Forward Brunswick will include a Steering Committee and Standing Committees

- **Steering Committee**: Identify and prioritize of key issues, concerns, initiatives, opportunities and, ultimately, specific projects.
 - o Identification and recruitment of key "missing" stakeholders & representatives
 - Coordination of Initial Feasibility Studies
- **Standing Committees**: Focus on <u>categories</u> of concerns and opportunities.
 - Receive recommendations from Ad Hoc committees formed around specific opportunities/projects.
 - Look for overlap and coordination with other recommended specific opportunities/projects, and refine feasibility assessments prepared by Ad Hoc committees, if necessary.
 - Present recommendations to Steering Committee for approval and prioritization.
 - Members stay on Standing Committees for indefinite periods.
