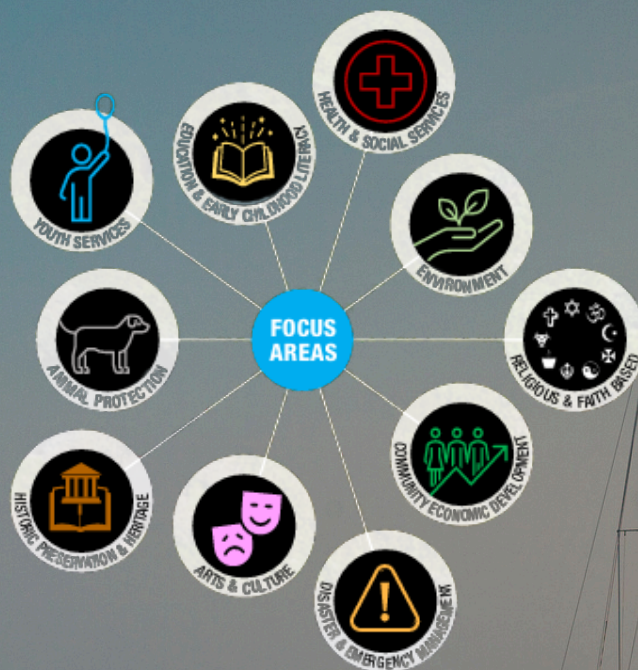

### Our Funds

### Field of Interest funds
